AGGREGATION ANALYSIS

- 76.57% of individuals supported take medications
- 32.35% of individuals aged 16 and older re employed
- 29.41% of individuals supported utilize one or more adaptive equipment's
- Additional safety questions should be included in the Safety Assessment:
 - o Do you know how to shut off the gas supply to your home?

- o Do you know how to shut off the water supply to your home?
- o Do you know what food items can and should not be microwaved?
- o Do you know how to turn off and on the stove? Oven?
- O Do you have a first aid kit at your home?
- Living arrangement must be considered during analyzation.
- Data entry must be done through software Provide to avoid human aggregation mistakes. Provide "Attributes" will suffice.
- There is a large need for individuals supported to learn cooking skills.
- There is a large need for individuals supported to learn and understand their medications.
- Many individuals supported are relying on others, such as parents, to keep their home and environment clean. Learned helplessness is a concern.
- Identifying and maintaining smoke detectors within homes should be part of Safety Drills submitted by Direct Support Professional (DSP) through AccelTrax.
- Online software must be expanded to provide individuals supported and/or guardians
 access to health information and records. Recreational Therapists should consider
 learning medical histories as possible goals and objectives during treatment planning.
 Direct Support Professionals (DSP's) should review Risk Plans and Person-Centered
 Individualized Support Plans (PCISP's) with individuals supported.
- Safety supplies missing from homes should be provided By whom?
- The Safety Assessment is intended to be quick and to the point. There should be follow up to failed criteria. For example, if the individual does not have to clean their home or environment, why? Does the individual understand the consequences of not cleaning? The Direct Support Professional (DSP) and/or Recreational Therapist must determine the initiative of the individual supported, providing empathy rather than sympathy.
- Potential programs/ events to address commonalities regarding cleanliness and personal hygiene difficulties revealed within the Safety Assessment include a dog/pet car wash fundraiser, Tough Mudder events, color run, mud sliding, or off roading
- How will the Safety Assessment be re-assessed when included only in the Individual Intake Form? Should the Safety Assessment occur thereafter? At what intervals? Who will conduct the Safety Assessments?
